Late bids will be rejected. Bids will be opened after bid submission deadline as mentioned above in the presence of representatives including bidders' (who choose to attend in person) at Municipality Office, Jhapa.

5. All bids shall be accompanied by a valid bid security of an amount not less than the amount as specified below. The bid security guarantee shall confirm to the standard format as specified in the bid document.
